## DANCE GUEST FORM The Governor's School for the Arts

Dance guests must agree to the following:

- 1. Any guest who does not attend The Governor's School for the Arts must submit this recommendation from his/her employer or school official. Family members may NOT sign the form. If the guest is a GSA graduate, the form **MUST** be signed by Dr. Shelly, Deborah, or the Department Chair. Falsifying information on this form will result in the guest being prohibited from attending the event.
- The guest will abide by all GSA rules and policies (student dance guidelines on the back of this page) while attending the dance. The dance is a school event, and no alcohol, drugs, or nicotine products/vapes are permitted at any time on the grounds of the dance site.
- 3. Any guest or GSA student believed to be under the influence of alcohol or other substance will be removed from the dance immediately and the parent/guardian will be contacted. Additional discipline will occur in accordance with the GSA Student Handbook.
- 4. Failure to comply with the rules will result in the guest being asked to leave immediately. Any guest asked to leave the event will not be permitted to attend any future dance.
- 5. GSA students may only bring ONE guest to the dance. Guests must be in at least 9<sup>th</sup> grade and may not be over 20 years old.
- 6. The guest ticket is non-refundable and non-transferable. The guest's name at the time of purchase must match at the check-in table on the evening of the dance. Guests should be prepared to provide a photo identification card at check-in.
- 7. All students attending the dance will be subject to security checks.
- 8. Guest forms are due to the GSA Office by Friday, March 14, 2025.

## **Student Dance Guidelines**

Students and guests must try to avoid excessive crowding on the dance floor.

Crowd surfing and lifting individuals into the air or on shoulders is prohibited by the venue.

All guests must complete the Dance Guest Form and GSA administration must approve.

All guests must present their high school ID or their driver's license for entry.

Only one guest per GSA student.

Re-entry will not be permitted after leaving

- All guests must be in at least 9<sup>th</sup> grade and be no more than 20 years of age.
- GSA students are responsible for informing guests of all expectations in the GSA Student Handbook, which must be followed by all attendees.
